In further addition, the actor types BRP and Trader also need to sign an Imbalance Settlement agreement with eSett.

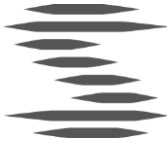


Actor type	General description
Retailer	<ul style="list-style-type: none">• A Retailer buys electricity and sells it to its customers on the free market in competition with other retailers.
Distribution System Operator	<ul style="list-style-type: none">• A Distribution System Operator maintains the grid and is responsible for transporting the electricity from the production units to the customers.
BRP	<ul style="list-style-type: none">• A Balance Responsible Party balances the consumption within its responsibility by using production and trade.
Energy Service Company	<ul style="list-style-type: none">• Helps its customers with e.g. energy efficiency and consumption statistics issues. Is registered as a Service Provider.
Trader	<ul style="list-style-type: none">• A Trader trades with electricity, but has no final customers
Service Provider	<ul style="list-style-type: none">• A Service Provider can among other things act on behalf of another actor
BSP	<ul style="list-style-type: none">• A Balance Service Provider is responsible for the delivery of ancillary services. To become a BSP the actor needs to be an approved BRP. A BSP also needs pre-qualified resources.

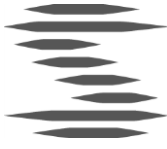
